Amendments to the Current Legislation of the Republic of Kazakhstan for the Period from October 20 through November 30, 2003

According to our electronic legal library, about 70 normative acts were adopted in the Republic of Kazakhstan October-November 2003.

This Information Memorandum covers the most important from the practical perspective or interesting, in our view, normative acts.

Laws of the Republic of Kazakhstan

1. Law of the Republic of Kazakhstan No. 490-2, On the State Support of Property Monitoring in the Strategic Economy Sectors, dated October 4, 2003

[The above normative act determines main requirements to the monitoring, data collection, analysis, assessment, and forecasting of the state of the property structure and management effectiveness of the property objects in the strategic economy sectors that include production and processing of fuel and energy minerals (coal, oil, gas, uranium, and metal ore), machine—building, chemical industry, transport and communication, production and distribution of electric power, and sectors producing products of military—industrial purposed.];

2. Law of the Republic of Kazakhstan No. 488-2, On Amending the Law of the Republic of Kazakhstan On Grain, dated October 13, 2003

[The above normative act introduces amendments related to the concepts, including the definition of the holder of the grain receipt and the pledge certificate, etc.];

Law of the Republic of Kazakhstan No. 496-2, On Ratification of the Agreement between the Government of the Republic of Kazakhstan and the Government of the United States of America About the Establishments of the Protected Communication Line Between the Center for the Control of the Reduction of Arms and Ensuring Inspection Activities Under the Ministry of Defence of the Republic of Kazakhstan and the Center for Nuclear Hazard Decrement of the United States of America, dated November 15, 2003;

[The above document identifies the criteria of the sufficient processing of goods used for the identification of the country of origin in accordance with the customs legislation of the Republic of Kazakhstan.];

3. Decree of the Government of the Republic of Kazakhstan No. 1067, On Amending Decree of the Government of the Republic of Kazakhstan No. 23 of January 10, 2002, dated October 21, 2003

[The above decree approves a new List of types of works (services) in the field of architectural, town-planning, and constructional activities subject to licensing.];
